### **Automated Unassigned Org Detection**

The application automatically detects and uploads unidentified member organizations with open chargeback errors into a loading area for verification.


The application then interfaces with customer DEA/HIN/GLN/HRIS-340B master data, cross-referenced with known contract class of trade information, to recommend an assignment. For multi-division organizations, the application has the ability to process membership validation separately by division.

### Work Flow Management

Manage work flow surrounding membership assignment and approval via a targeted work list

The **contract administrator** is presented with a work list of all unidentified members. Users can review and update class of trade assignments, and submit for review.

Once **managers** approve the assignment, only approved membership assignments are uploaded to your contract management system to resolve open chargeback errors.



#### **Role-Based Application Views**

Multiple roles allow access to different views/ levels of functionality

The application supports multiple roles with different levels of access:

#### **Membership Administrator**

- View work list of unassigned members.
- Assign members and submit for approval.

#### **Membership Approval Manager**

- View work list of submitted assignments.
- Review assignment and reassign.
- Ability to approve and upload.

#### **System Administrator**

- Maintain users and user roles.
- Maintain processing exceptions.
- Maintain cross-reference data.

### Contract Org/COT Reconciliation

Reconciliation of contract organization codes and class of trade indicators
